ASX ANNOUNCEMENT

<u>CLASSIC POURS FIRST GOLD BAR - Clarifying Announcement.</u>

Classic Minerals Ltd ("Classic" or the "Company") (ASX: CLZ) provide the following clarifications to the announcement of 17 August 2023.

The Company advises that there are still a number of steps that need to be completed before becoming a producer. These are Trial Mining and Ore Reserve determination. The Company estimates 2 months for completion at a cost of ~\$ 1.5 million. The Board is undertaking this to enable Classic Minerals Limited to be qualified to go into production.

Classic has poured a bar of gold Dore from the gold recovered through the gravity circuit by processing 989 tons of ore from the 6,504 tons¹ of ore mined from the Bulk Sample.

Furthermore, the reference to the projected recovery rate of 98% is obtained from page 3 of the ASX announcement of 10 October 2022, and that paragraph is reproduced below for clarity:

The Gekko plant, followed by a grinding and leaching circuit has been shown to **demonstrate 98% gold recovery in metallurgical testwork.** The ore type is a typical free milling non-refractory ore type that is common in the eastern goldfields; with recoveries ranging from 95% and higher for most of these ore types when milled with reasonable diligence.

The Company is proceeding to a trial mining phase which will enable an Ore Reserve to be determined, which would include all costs and recoveries.

The gold bar has been produced for refining and obtaining the metal characteristics from The Perth Mint. This metal characterisation will enable further analysis and optimising the processing of the ore.

Please note that the production of the gold bar does not mean the relevant project is about to go into production; and whether the project will go into production will depend on the steps discussed in paragraph 2 above.

About Classic Minerals Ltd

Expanding its focus from exploration to mining, West Australian-based, minerals house Classic Minerals Ltd holds a pipeline of projects and continues to examine new opportunities both cyclic and countercyclic. Currently, ASX-listed Classic holds approximately $578\,\mathrm{km^2}$ of tenements across two major regional exploration areas in minerals-rich West Australia. Classic's ground is in areas with identified high grade gold and base metal targets. Classic's flagship Kat Gap Gold Project has been the recent focus of its exploration, mining and processing efforts and is strategically located some 170 km south of Southern Cross and some 50 km south of the Company's Forrestania Gold Project. With strong grades and near-surface mineralisation Kat Gap is soon to attain full scale production.

ABOUT THE FORRESTANIA GOLD PROJECT

The FGP Tenements (excluding Kat Gap) are registered in the name of Reed Exploration Pty Ltd, a wholly owned subsidiary of ASX listed Hannans Ltd (ASX: HNR). Classic has acquired 80% of the gold rights on the FGP Tenements from a third party, whilst Hannans has maintained its 20% interest in the gold rights. For the avoidance of doubt Classic Ltd owns a 100% interest in the gold rights on the Kat Gap Tenements and also non-gold rights including but not limited to nickel and lithium.

Classic has inferred and indicated mineral resources of **8.41Mt at 1.45** g/t for **391,417** ounces of gold, classified and reported in accordance with the JORC Code (2012), with a recent Scoping Study (see ASX Announcement released 2nd May 2017) suggesting both the technical and financial viability of the project. The current post- mining Mineral Resource for Lady Ada, Lady Magdalene and Kat Gap is tabulated below. Additional technical detail on the Mineral Resource estimation is provided, further in the text below and in the JORC Table 1 as attached to ASX announcements dated 18 December 2019, 21 January 2020, and 20 April 2020.
